

Monthly Release of
Foreign Trade Statistics (FTS)
June 2016

Bangladesh Bureau of Statistics (BBS) of Statistics and Informatics Division (SID) compiles and publishes Foreign Trade Statistics (FTS) on a regular basis. This publication presents monthly trend of Bangladesh foreign trade statistics including statistics on top trading partners, essential import commodities, and last twelve months scenario of major export and import goods for June, 2016.

Merchandise trade data of this publication are provided by National Board of Revenue (NBR) and while data on services from Bangladesh Bank. Data presented in this publication are provisional and subject to revision. All these provisional data will be subsequently reviewed and revised. Revised data are being presented in next issues.

In June, 2016, total export and import of goods and services is recorded at Tk. 305.85 and Tk 414.30 billion respectively resulting in a trade deficit of goods and services of Tk.108.45 billion. The growth of export and import in June, 2016 is 18.69 and decreased by 2.53 percent respectively comparing to May, 2016 and it is 1.22 and 1.15 percent respectively comparing to June, 2015.

For the three months ending in June, 2016 the moving average of export of goods and services was Tk.265.44 billion, while the moving average of import of goods and services was Tk.398.07 billion resulting in an average trade deficit of Tk.132.63 billion. For the three months ending in May, 2016 the average trade deficit was Tk. 138.18 billion, reflecting average exports of Tk.245.05 billion and average imports of Tk.383.23 billion.

Indicators of this publication are expected to provide a good idea about the trend of export and import of the country over the previous months of a year. This monthly release would be a useful document for planners, policy makers, researchers, development partners/agencies, academicians and other stakeholders.

Graph 01. Export and Import By Month

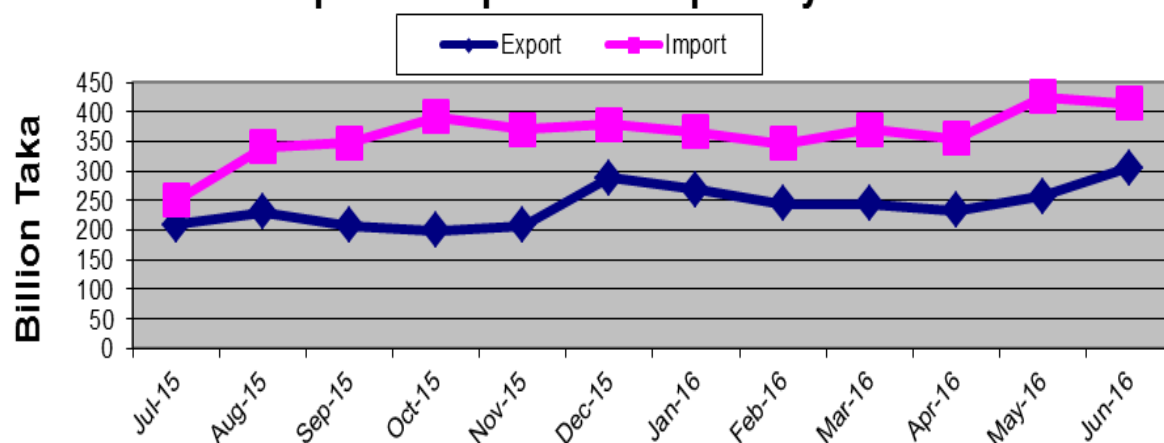

Graph 02. Export and Import By Month

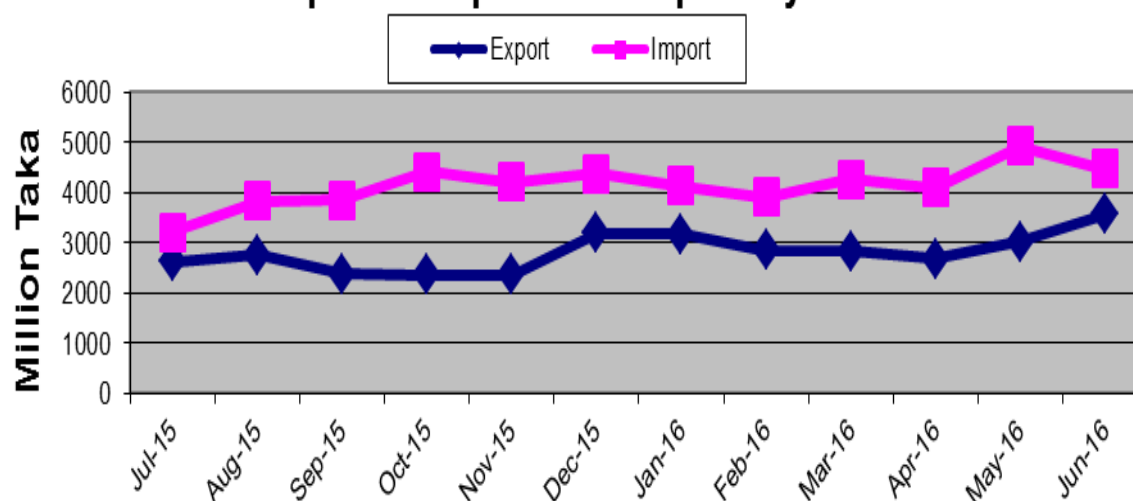

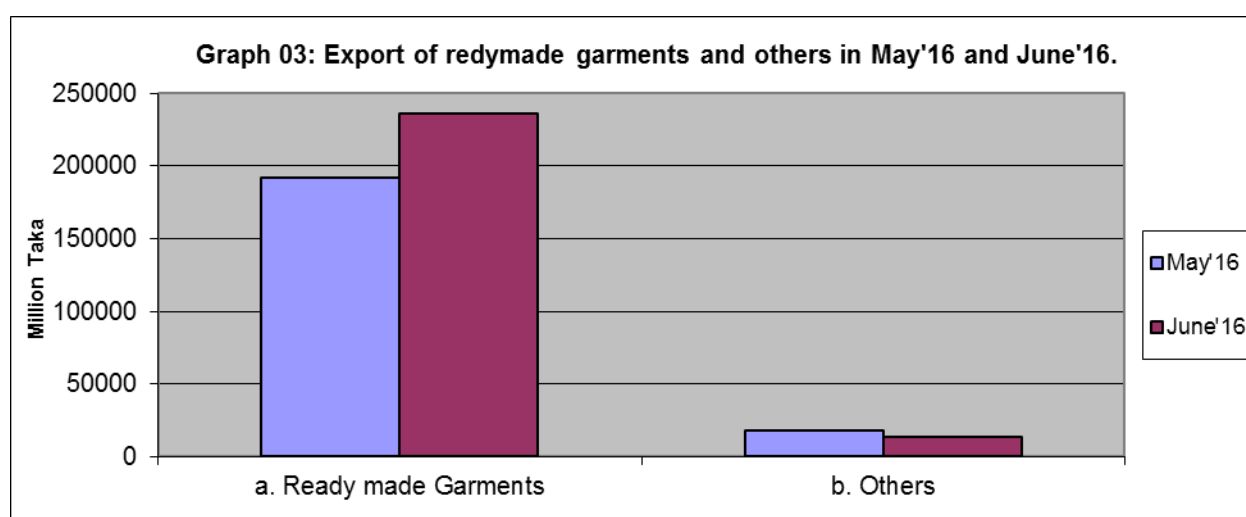

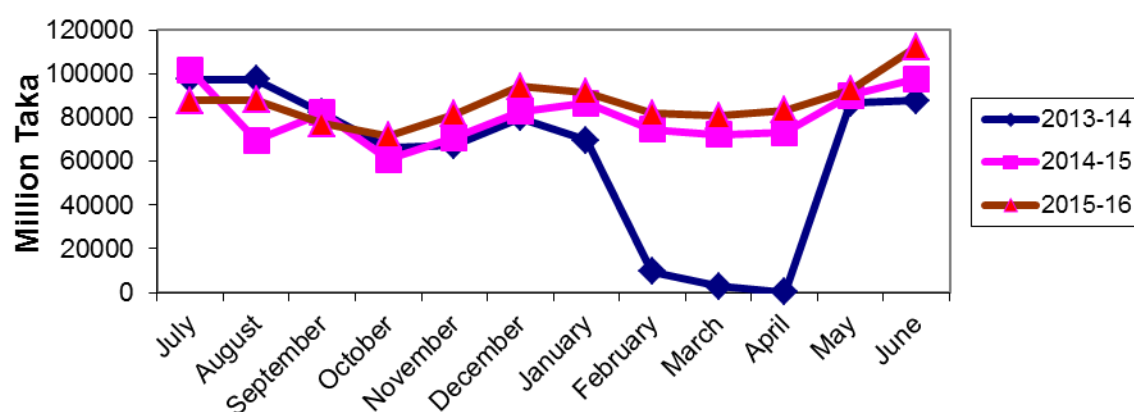

Graph 05: Twelve months exports of readymade garment (not knitted) .

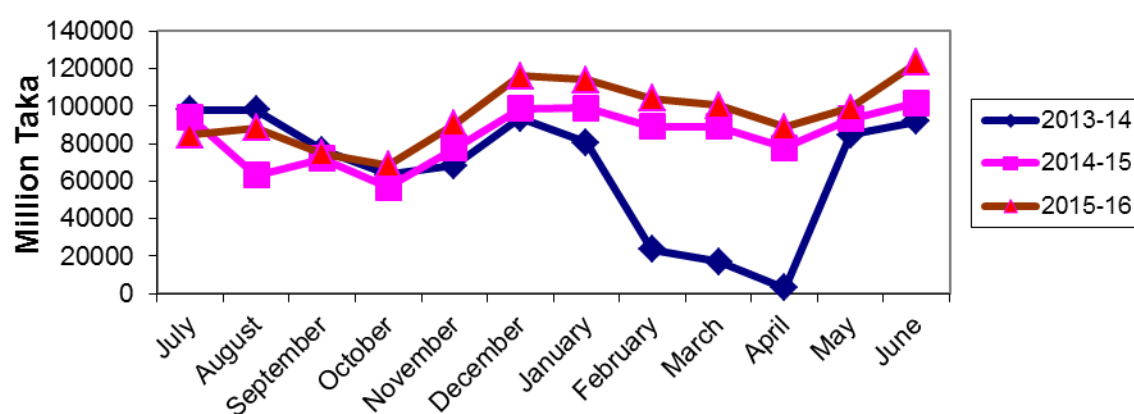

Graph 06: Twelve months exports of raw hides, skins & leather .

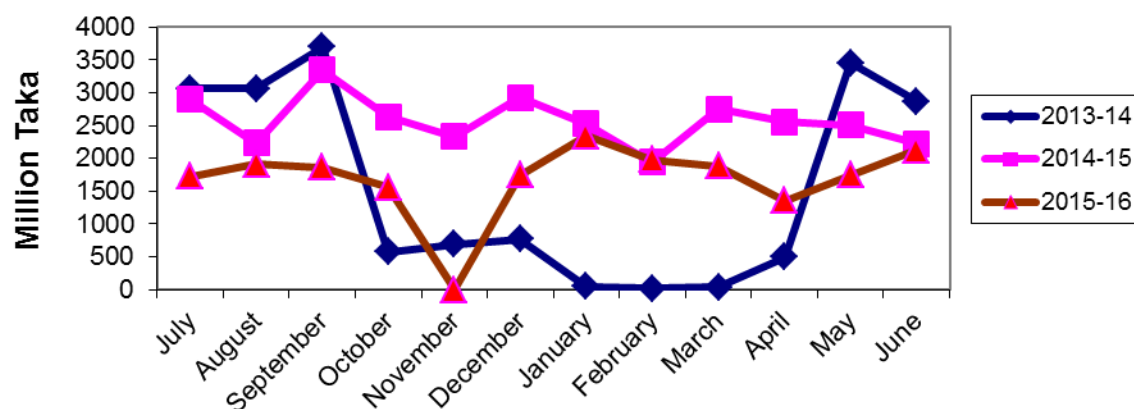

Graph 07: Twelve months exports of shrimps & prawn .

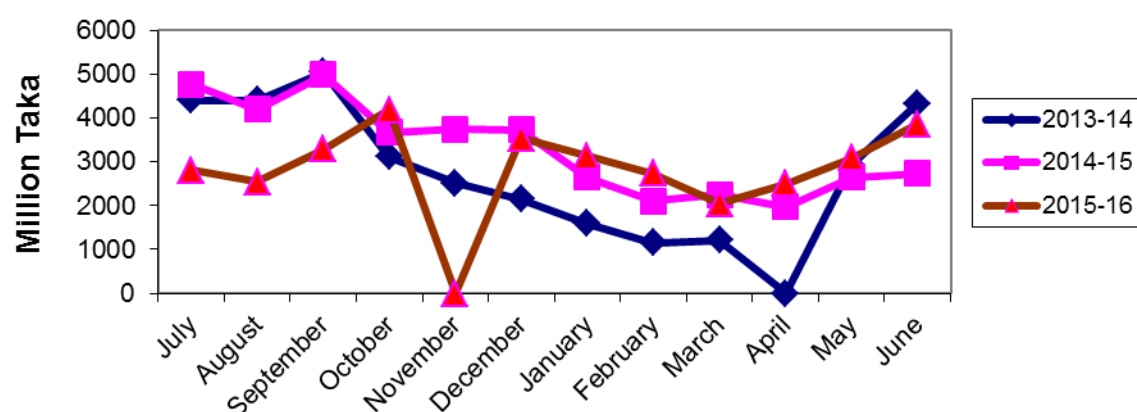
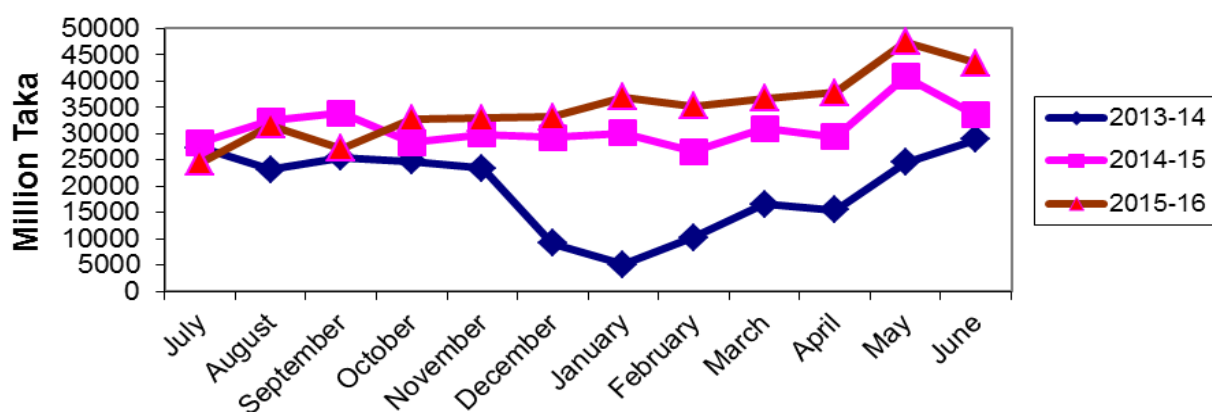

Graph 09: Twelve months imports of electrical machinery .

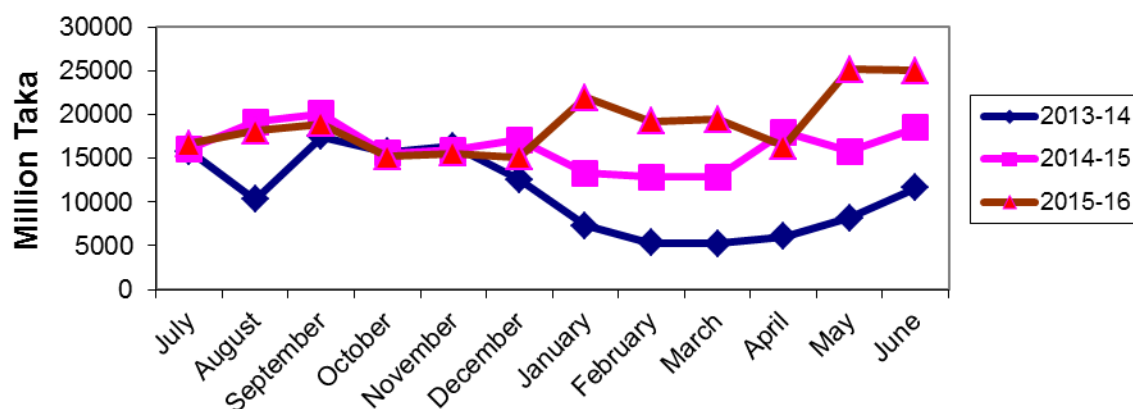
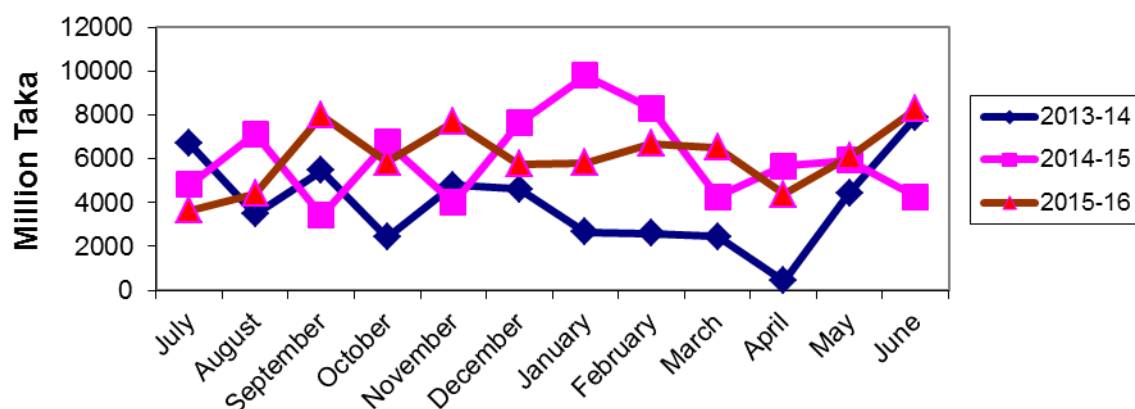

Graph 10: Twelve months imports of soyabean oil .



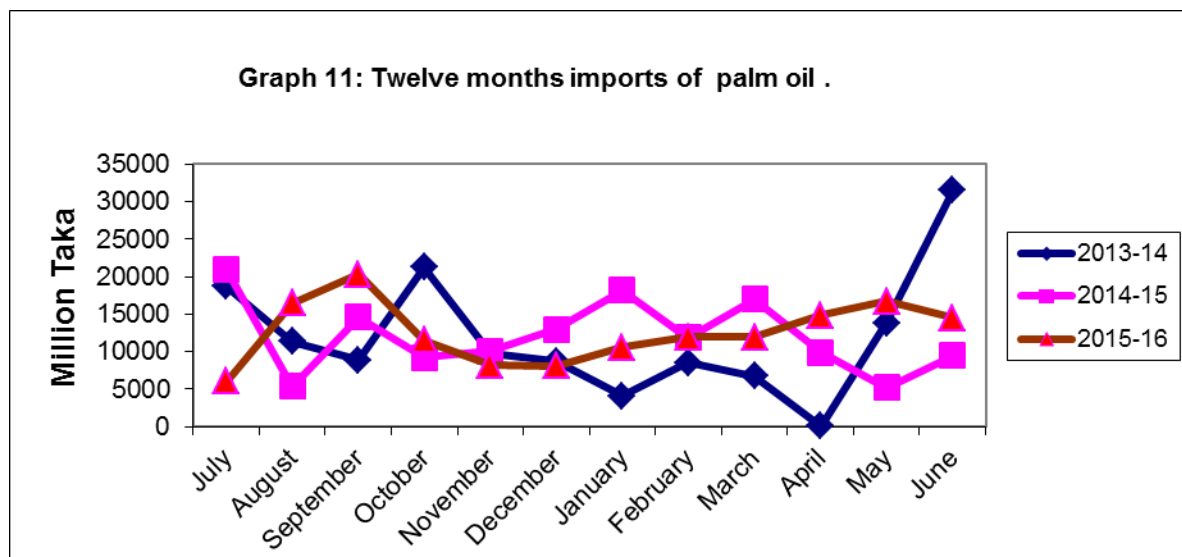
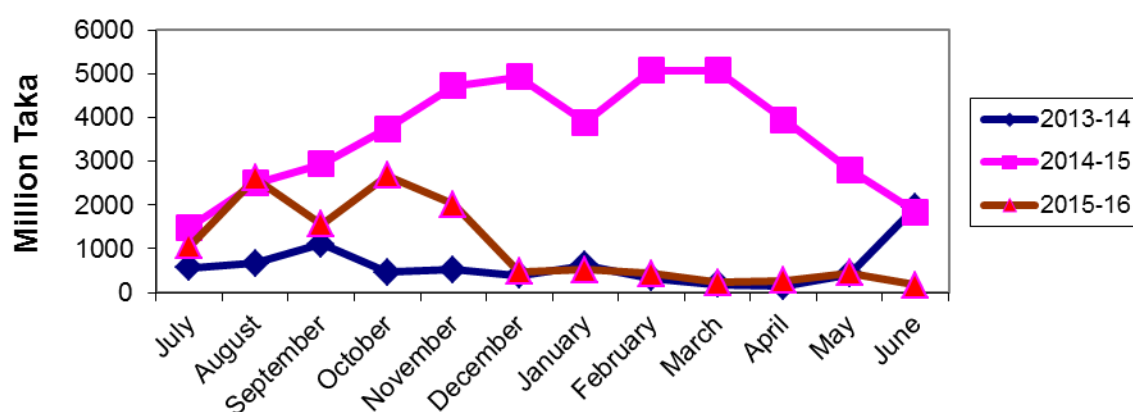

Graph 13: Twelve months imports of wheat .

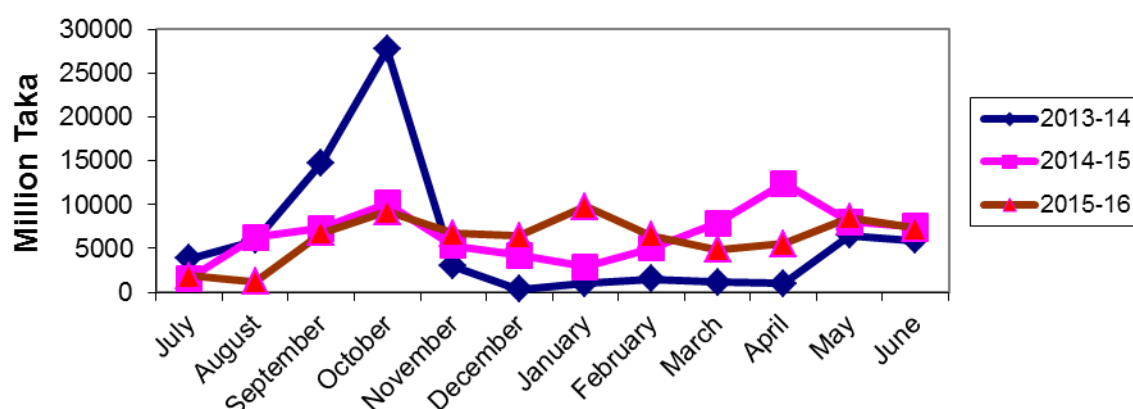
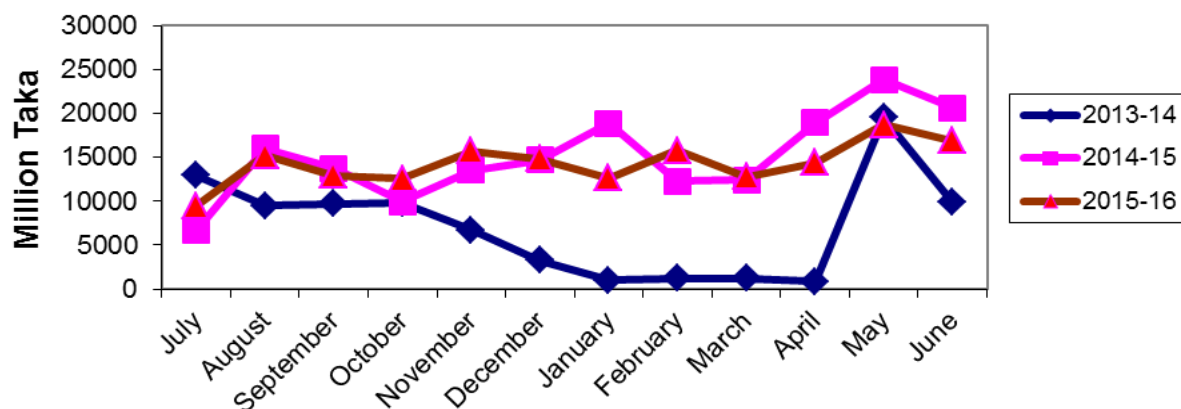

Graph 15: Twelve months imports of plastics & articles .

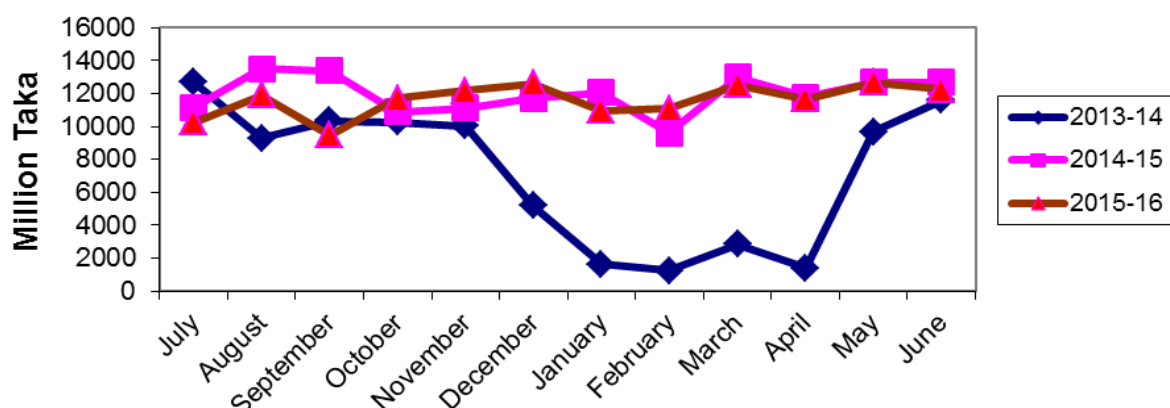

Graph 16: Top trading partners – total trade (goods), June'2016.

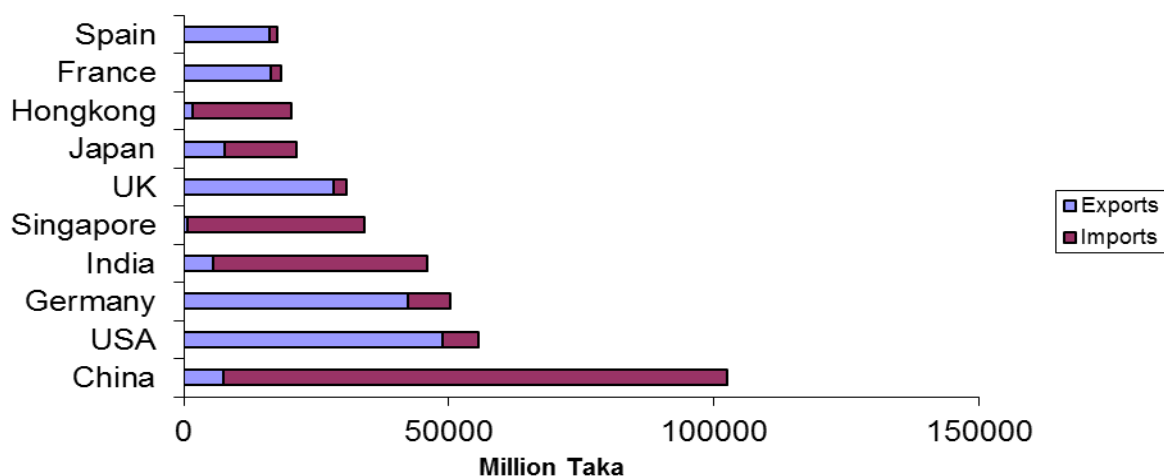
