## **Executive Summary**

Bangladesh Bureau of Statistics (BBS) compiles and publishes Foreign Trade Statistics (FTS) on a regular basis. This publication presents monthly trend of Bangladesh foreign trade statistics on top trading partners, essential import commodities and last twelve months scenario of major export and import goods specially for January, 2024.

Merchandise trade data of this publication are provided by National Board of Revenue (NBR) while data on services from Bangladesh Bank. Data presented in this publication are provisional and subject to revision. All these provisional data will be subsequently reviewed and revised. Revised data are being presented in next issues.

In January, 2024 total export and import of goods and services is recorded at increased by Tk. 696.97 and increased by Tk. 904.65 billion respectively resulting in a trade deficit at goods and services of Tk. 207.68 billion. The growth of export and import in January, 2024 increased by 9.37 and increased by 11.19 percent respectively comparing to December, 2023 and it is increased by 18.41 and increased by 4.71 percent respectively comparing to January, 2023.

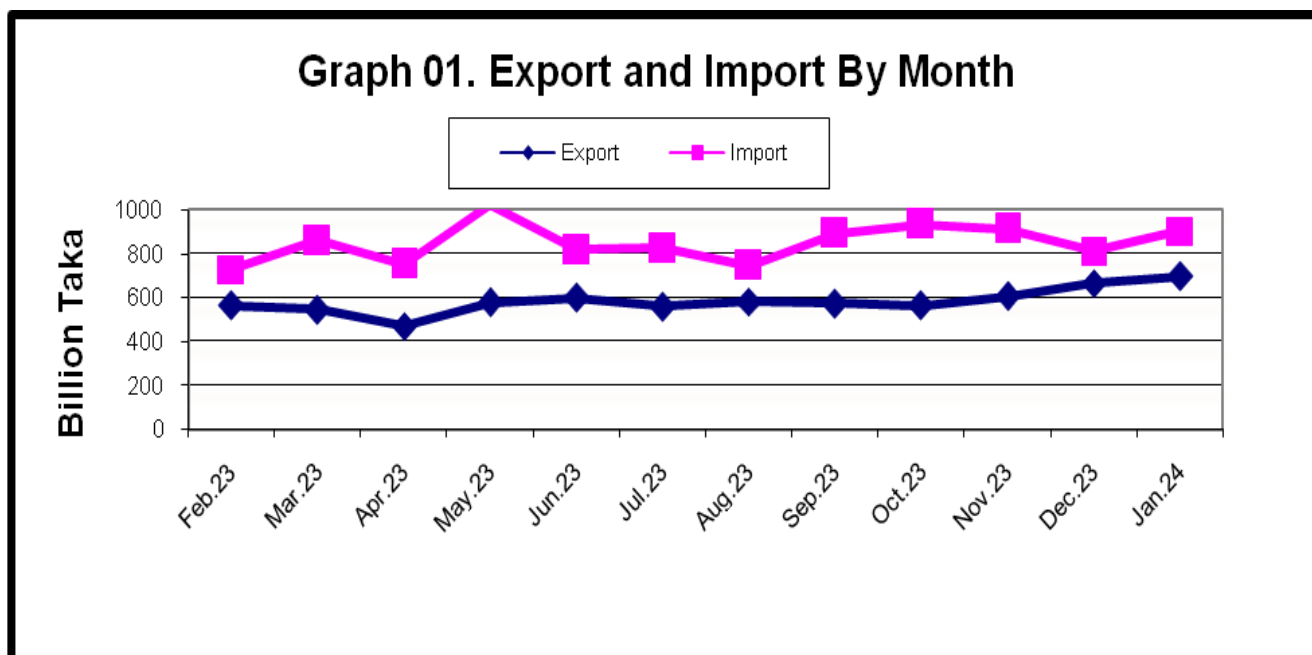
For the three months ending in January, 2024 the average of export of goods and services was Tk. 657.73 billion, while the moving average of import of goods and services was Tk.877.98 billion resulting in an average trade deficit of Tk.220.25 billion. For the three months ending in December, 2023 the average trade deficit was Tk. 284.86 billion reflecting average exports of Tk. 613.84 billion and average imports of Tk. 888.18 billion.

Indicators of this publication are expected to provide a good idea about the trend of export and import of the country over the previous months of a year. This monthly release would be a useful document for planners, policy makers, researchers, development partners/agencies, academicians and other stakeholders.

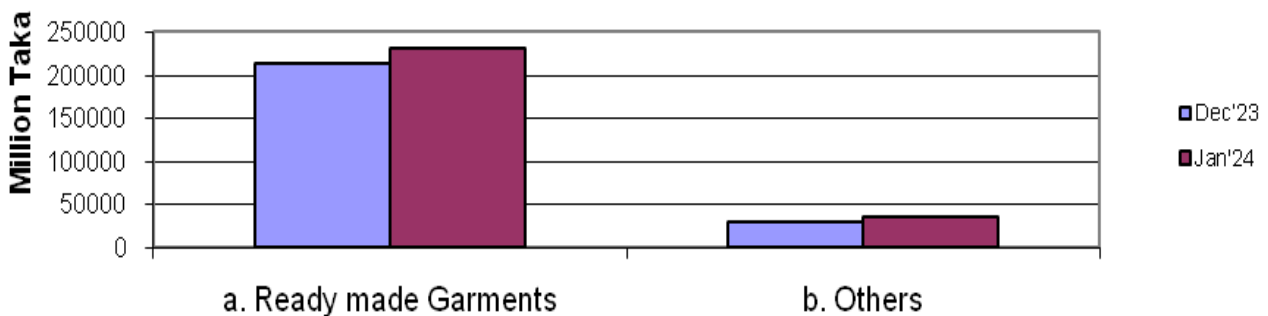

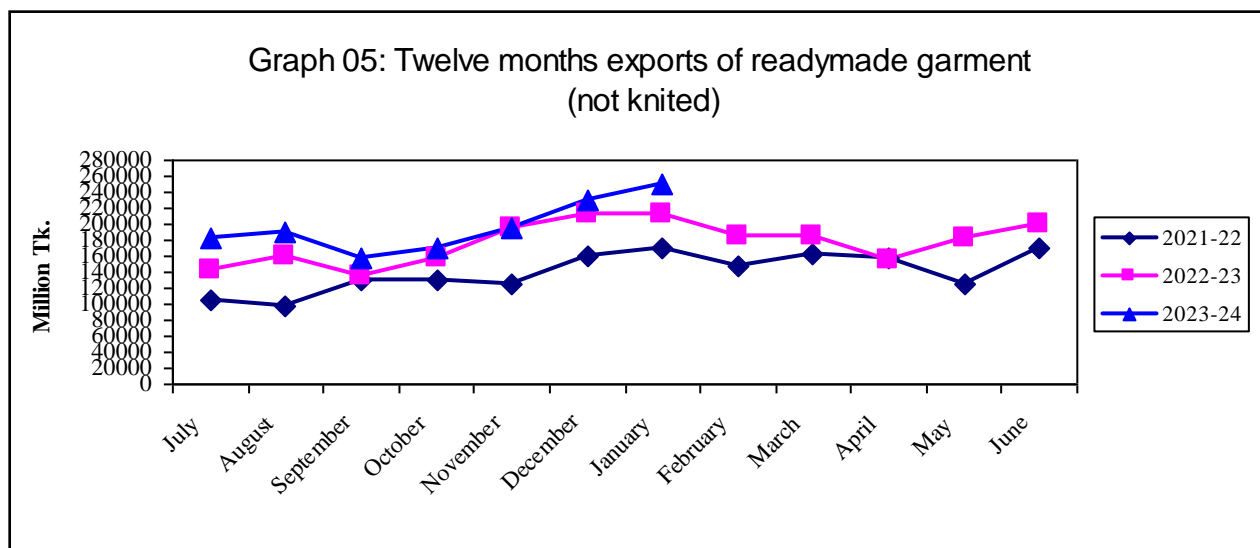

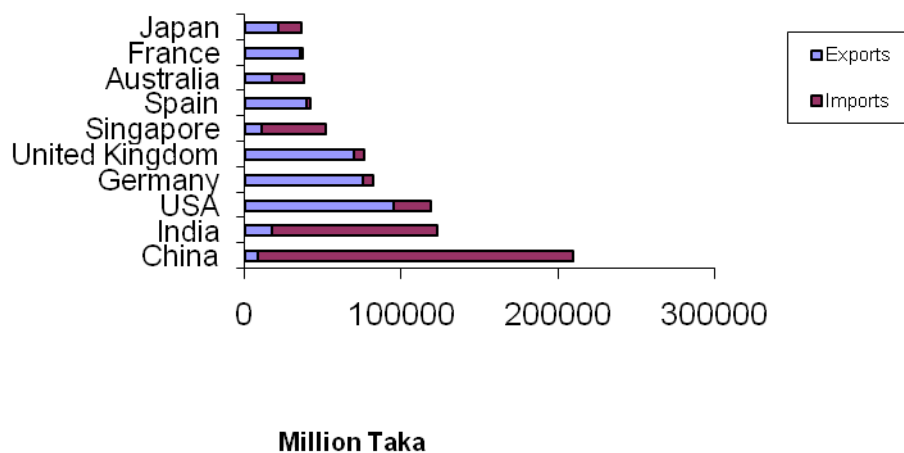
