

**Monthly Release of**  
**Industrial Production Statistics (IPS)**  
**October-2023**

Bangladesh Bureau of Statistics (BBS) of Statistics and Informatics Division (SID) compiles and publishes Industrial Production Statistics (IPS) on a regular basis. This publication presents data on industrial production for selected Large, Small, Medium, Micro and Cottage scale manufacturing industries along with the monthly estimates of Index of Industrial Production (IIP) for **October 2023**. The base year of the IIP is 2015-16.

To assess movement of industrial production in Bangladesh, data are collected from State Owned Manufacturing Enterprises (SOEs) and major manufacturing enterprises in private sector on sample basis. For compilation of IIP, production data are collected every month from a total of 1907 sample industries under 74 four-digit level classes ISIC, Rev.4

Indicators of this publication are expected to provide good idea about the trend of industrial production in the country over a long time. This monthly release would be a useful document for planners, policy makers, researchers, development partners/agencies, academicians and other stakeholders.

Suggestions and comments for further improvement of this publication will be highly appreciated.

Bangladesh Bureau of Statistics (BBS) as a National Statistical Organization (NSO) is a vital interface between national policies in the economic, social and environmental sphere, national policies, programs. It has been engaged in collecting, collating and disseminating statistics on a wide range of various variables. It is an important activity of BBS to compile and publish the Index of Industrial Production (IIP) on a regular basis. IIP is a key short-term indicator of economic performance in the manufacturing sector since industrial production is one of the more dynamic and fluctuating elements in the economy. It serves to assess the significance for the economy as a whole, changes in the volume of industrial output and the relationship of IIP change with the change in national income, price, foreign trade and other aggregates.

**2) International Recommendations and Guidelines used for the compilation of Index of Industrial Production (IIP):** The United Nations Statistics Division (UNSD) has issued the two following related publications which address the international standard recommendations and guidelines and these are followed for underlying the compilation of Index of Industrial Production (IIP).

1. The International Standard Industrial Classification of all Economic Activities (ISIC) Rev.4 is the latest version of Classification that is used to define industrial production for international comparability. Bangladesh Bureau of Statistics has prepared its activities classifications at detailed levels entitled Bangladesh Standard Industrial Classification of all Economic Activities (BSIC) fitted into ISIC and adapted this system of classification as national standard.
2. The International Recommendation for the Index of Industrial Production 2010 that is used for the related fundamental concepts, definitions, principles, methods in great detail to obtain industrial production volume, sources of data, compilation procedure and additional compilations issues as like revision and shifting of base year.

### 3) Key notes of rebasing IIP, related concepts and definitions:

1. **Industrial Production:** The System of National Accounts describes production as an activity carried out under the responsibility, control and management of an institutional unit that uses inputs of labor, capital and goods and services to output of goods and services.

2. **Manufacturing:** It is the physical or chemical transformation of materials, substances or components into new products.

3. **Gross Value Added (GVA):** Gross Value Added is the value of output less the value of intermediate consumption (materials and purchases services).

4. **Index of Industrial Production (IIP):** IIP describes the change of the volume of goods and services produced over time. Its main purposes is to provide a measure of the short-term changes in the value added over a given reference period. It is not influenced by price fluctuation.

4) **Shifting of base Year:** The production of goods produced in the economy is changed in positive or negative over time. It is urgent to change the base year for IIP to reflect the changing structure of the economic activities. BBS has done this gigantic work as like shifting the base year from 2005-06 to 2015-16. It is compiled on monthly basis.

5) **Classification:** The index has been compiled by three categories considering the total person engaged in the establishment for the revision, review and rebase of base year.

1. IIP- large Scale (TPE: 250 and above)
2. IIP- Small Medium and Micro Scale (SMMI), (TPE: 10-249)
3. IIP-cottage Scale (TPE: 1-9)

6) **Derivation of Weight:** The weight for IIP-Large scale and IIP-SMMI is determined at 4-digit level class on the basis of GVA using updated survey of Manufacturing Industries (SMI) 2019 and the weight for IIP-Cottage is derived from Cottage industry survey 2011.

$$\text{Contribution of a group (Weight)} = \frac{\text{Value Added of the group}}{\text{Total Value Added of All group}} \times 100$$

7) **Updating Sample frame:** A business register is an essential tool for the source of sampling frame. But the establishment may merge; split up, or go out of business, change production activities, move location, birth of new establishment and death of existing establishment. So it should be updated to coincide with the current information as

representative as possible. In this respect the existing Business Register has been updated through the field office to develop the sampling frame of IIP.

**8) Selection of sample:** At the first stage all manufacturing unit is stratified into 3 categories. At the second stage each of the three categories is stratified at 4-digit level class of ISIC, Rev.4. Then the sample for IIP-Large scale and IIP-SMMI is selected using two stages stratified random Sampling method from business Register 2018 and the sample for IIP-Cottage scale from Economic Census 2013.

#### **Sample Size for each category**

1. IIP- large Scale: 720
2. IIP- Small Medium and Micro Scale: 620
3. IIP-cottage Scale: 700

**9) Aggregation:** The index of industrial production covers 1) Mining and Quarrying, 2) Manufacturing 3) Electricity, Gas, Steam and Air Conditioning supply outlined in the ISIC Rev.4. Manufacturing is further disaggregated by 74 classes at 4-digit level.

**10) Data Collection:** Prior to data collection, in-depth training was imparted for data collectors and supervisors of the field level and head quarter of BBS. There were about 200 data collectors and 93 supervisors from 64 District Statistical Offices, 8 Divisional Statistical Offices and Head Quarter of BBS. The district wise data collection team was formed about 2-10 persons depending on the number of establishments of each district.

**11) Data Entry, Processing and validation:** After the completing data collection, the filled-in- questionnaires were sent to the BBS Headquarter. Then the transfer data were promptly examined, verified and calculation of Index.

**12) Index Calculation:** It is a weighted average of the relative changes in the quantities of a specified set of goods and services between two periods of time. The weights of some fixed base period are used for the Laspeyre's index and it can be expressed as:

IIP= Index of Industrial Production

$q_{ti}$ = Quantity Commodity Produced in the Current year

$q_{oi}$ = Quantity Commodity Produced in the base year

$w_{oi}$ = Weight of Commodity in the base year

$n$  = Number of Commodity included in the index

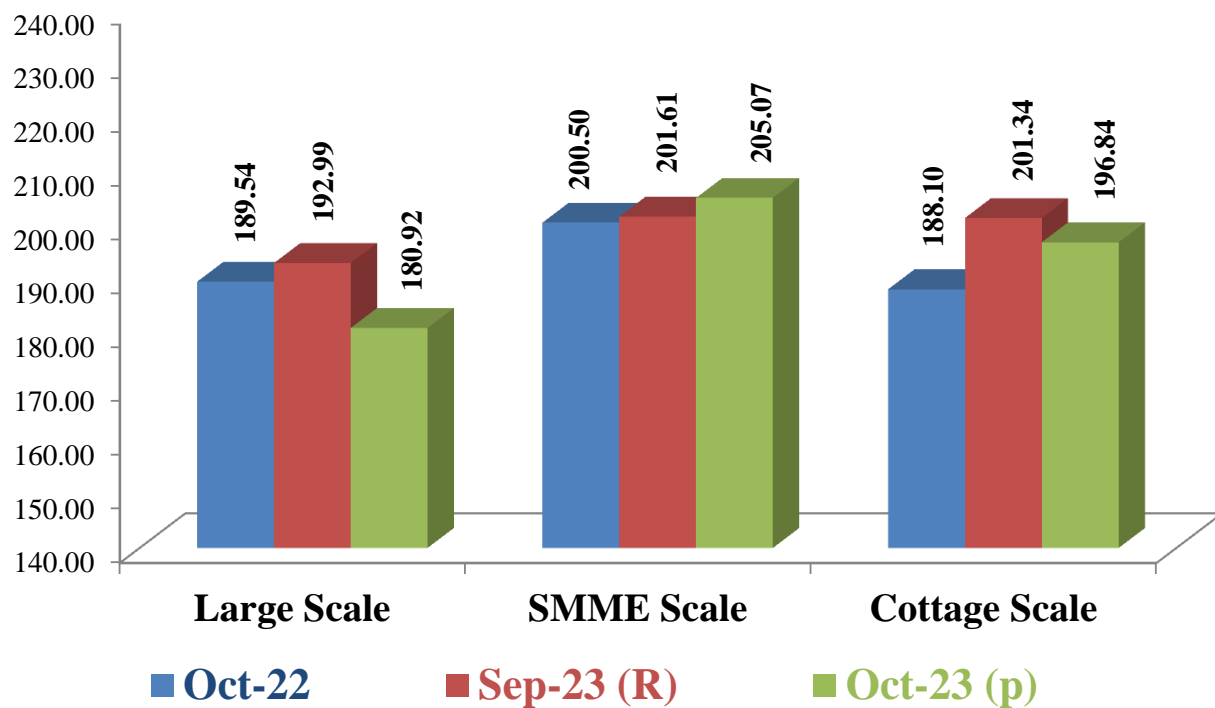

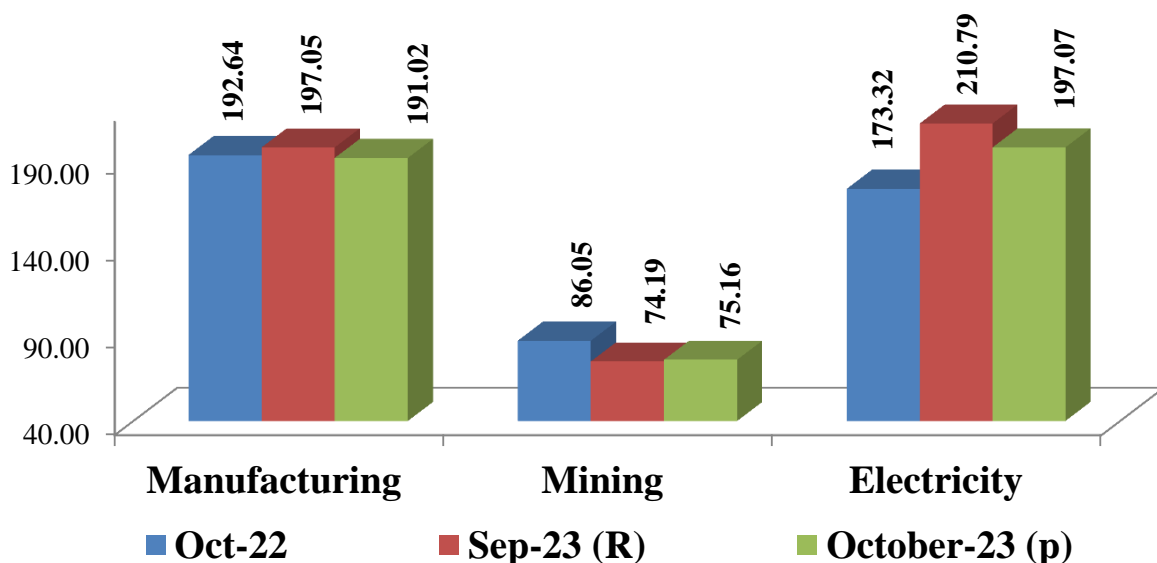


**Chart on Index of Industrial Production of Manufacturing Enterprise: October-2023**
