Terms of Reference for Individual Consultant: Database Management Specialist

1. Introduction and Background

The National Household Database (NHD) Project has been being implemented by the Bangladesh Bureau of Statistics (BBS) since July 2013 through a collaborative arrangement of Government of the People's Republic of Bangladesh (GoB) and the World Bank (WB). Both technical and financial assistance are received from the World Bank in implementing the project. The NHD project has a provision for engagement of a Database Management Specialist (DMS) in the capacity of an Individual Consultant. The consultant would work closely with BBS and Department of Disaster Management (DDM) to provide MIS/IT related technical guidance and support to facilitate smooth implementation of MIS/IT aspects under NHD project. The project will end in June 2021.

2. Objective of the Assignment

The main objective of this assignment is to hire a qualified Database Management Specialist to closely work with NHD Project/BBS and provide necessary technical guidance and support in MIS/IT related aspects that will evolve during the MIS design, development and implementation phases.

3. Scope of Services

The DMS will work under the supervision of the Project Director and will be responsible for the overall database development and management activities of the project. Key responsibilities include, but are not limited to:

- Develop and document an MIS development plan based on the project objectives and taking consideration of existing IT system and infrastructure to address the MIS design issues and implementation challenges.
- Assist BBS in supervising and reviewing the tasks undertaken by the ICT service provider (such as MIS firm, data collection and processing firm, etc.) during crucial phases, that include system requirement phase, MIS design phase, implementation of the MIS, testing, training, data migration, operational acceptance testing to ensure that the system is well designed and in accordance with the original technical specification. The consultant shall coordinate with the MIS firm at every process of the MIS development life cycle to ensure that specific requirements are made.
- Take active participation in supervising and coordinating all related ICT service providers (MIS firm, hardware supplier, data collection and processing firm, etc.) to ensure that the tasks are being performed as expected, provide all technical inputs, comments and suggestions on all technical documentation submitted by the service providers (MIS firm, data collection and processing firm, etc.) and ensure that all deliverables are of highest quality and standard that meets the overall project objectives.
- Identify and document potential technical issues, challenges foreseen during the MIS development period with clear recommendation and time bound action plan to mitigate such potential challenges for the higher management to take an appropriate resolution measure. Take part as a member of the evaluation committees.

- Develop a concrete action plan to roll out the system taking into consideration of data entry strategy, data collection, training and take a lead in its implementation.
- Identify training and capacity building needs for BBS staffs and relevant users at central and local levels to ensure long-term system sustainability.
- Closely work as a member of joint technical pool (BBS and DDM) to supervise and monitor the overall MIS development activities and progress made and complement each other's expertise and skills as necessary.
- Actively participate in technical meetings/discussions with various line ministries, counterparts, donors including the World Bank review missions, coordinate and harmonize with concerned stakeholders (Election Commission, Ministry of Health) that are supporting the MIS development and enhancement.
- Work closely with BBS and DDM counterparts to perform the relevant tasks and duties as advised to facilitate the effective implementation of NHD project.
- Plan the data migration mechanism from BBS to DDM and other organizations, ministries, etc. as per requirement.
- Support storage and analysis of data collected during surveys using automated tools like Computer Assisted Personal Interviewing (CAPI) and Computer Assisted Telephone Interviewing (CAPI) techniques.
- Plan and specify mechanisms as how the data from surveys can be amalgamated and synched with the poverty database to obtain effective analysis results.
- Any other task assigned by the Project Director.

4. Duration

Initially the duration of the consultancy services would be for 12 (twelve) months, which could be extended based on performance.

5. Institutional Arrangement

The Consultant will work under direct control of the Project Director. He will report directly to the Project Director with close collaboration with other officials and consultants of the project. He will be accountable to the Project Director for his day to day activities.

6. Reporting Obligations

The Consultant shall provide inputs for internal use as well as for other purpose and submit all kinds of reports related to his assignments as and when required by the Project Director and include the followings:
