1. Background

The Government of Bangladesh (GOB) approved the National Strategy for the Development of Statistics (NSDS) in 2013, together with the Statistics Act 2013, that envisages an "integrated, professional, efficient, and effective NSS, under the guidance and leadership of the BBS and to produce official statistics that meet the current and evolving needs of national and international users in a transparent and timely fashion using international standards". The NSDS Implementation Support Project (NSDS Project) is as an Investment Project Financing operation funded by the World Bank and will support the implementation of key elements of the NSDS strategy. The project development objective is to improve the capacity of the Bangladesh Bureau of Statistics (BBS) to produce quality core statistics and make them accessible in a timely manner to policy makers and the public.
